Last year at this time, I wrote to you about the pride I feel toward our synagogue. I am proud to preside over a forward-thinking institution that realizes that removing the financial barriers to access Judaism is of the utmost importance. We achieve this by continuing our self-directed, voluntary pledge structure.

Our numbers have grown, we have welcomed some lovely new families, and the warmth of our community has expanded.

With the implementation of our new pledge structure, we eliminated the building fund obligation. While we continue to be able to cover our operating expenses, it is now more difficult to maintain the needed reserves that we traditionally kept in our building fund. Therefore, I am asking you to please consider contributing to our capital campaign as your "end of year" donation. I have listed below the key areas which still need funding. Our goal under this campaign is to raise \$100,000. Please consider our need to address these projects, and give generously.

- Replacement of aging air conditioning and heating units
- Repair of aging roof
- Replacement of front walkway, ramp, and sidewalk concrete
- Repaving the parking lot

Through your generosity, some of our projects that I listed last year, have been funded and completed, or are in the process of being completed. These include:

- Upgrade of office computers
- Repair and replacement of parking lot lights
- Replacement of old and out-of-date lighting with energy efficient options
